Background

For the design industry to continue to flourish, nurturing the next generation of designers is essential. We must prepare students to navigate and succeed in the world that is emerging rather than the world of the past and present. In light of trends such as an ageing population, economic uncertainty, rapid adoption of digital technologies and artificial intelligence, and climate challenges, the Design Business Chamber Singapore (DBCS) believes that **future designers will require specific leadership qualities.**

This calls for a **renewed approach** to preparing and educating design students, and we acknowledge the Institutes of Higher Learning for leading this transformation and inspiring students to become leaders of the industry. Educating the next generation is a shared responsibility of institutions and industry, and, as a national chamber, DBCS would like to do our part by partnering with institutions in Singapore to shape future leaders and equip them with relevant skills, industry perspectives, and professional networks through mentorship and workshops.

About the Award

Organised by DBCS, the **Seed Award** serves as a forward-looking statement of how DBCS envisions design leaders who will flourish in the future. It seeks to broaden traditional measures of success in design education by recognising leadership qualities that are critically important and that will support graduates throughout their careers.

The award provides a platform for a wider group of students to **distinguish themselves as they enter** the design industry, and it also acknowledges and encourages Institutes of Higher Learning for supporting holistic student growth in both design craft and leadership development.

In this spirit, unlike traditional design awards judged primarily on finished work, the Seed Award recognises students for their demonstration of 5 designer qualities across study and practice, with Top Seed Awards from DBCS conferred on the top 10 among all of the awardees.






5 Designer Qualities

Process


All participating Institutes of Higher Learning will serve as the assessors for the Seed Award within their own institutions. Each institution should apply the DBCS guidelines and rubric consistently, and evaluate candidates on evidence that demonstrates the 5 designer qualities. Institutions are expected to ensure fairness and transparency by declaring and managing any conflicts of interest, calibrating scoring before and after reviews.

Each participating institution may grant the Seed Award to any number of eligible students within the institution. Within the submitted students, each institution can nominate up to 3 proficient and exemplary students for the Top Seed Award.

Institutions may submit any number of Seed Award recipients

Each institution nominates three recipients for the Top Seed Award

The DBCS Judging Panel selects ten Top Seed Award winners from all institutional submissions

Awardee Criteria

Awardees should be current students or recent graduates (within 1 year of graduation) of a design-related programme within your institution at the time of submission.

Institutions are asked to assess awardees against the 5 designer qualities when preparing submissions.

- 1 Creative Impact concerns the use of design to address real needs and to deliver positive, measurable outcomes for users, stakeholders, or society.
- 2 Critical Thinking concerns clear problem framing, evaluation of alternatives, and reasoned judgement in conditions of ambiguity.
- Connective Intelligence concerns empathy and collaboration across disciplines and communities, together with the ability to integrate human, nature, and digital considerations.
- 4 Perseverance concerns resilience, reflective learning, and sustained effort in the face of constraints or setbacks.
- **5 Ethical Decision-Making** concerns integrity, anticipation of consequences, and a demonstrable regard for the public good in design decisions.

Submission Guide

All awardee submission must be completed through the online form via www.seedaward.sg/submission

Every submission includes:

- 1 Submission Form, to be completed online
- 2 Administrative Fee invoiced by DBCS to respective institutions after completed submission Fee per student: S\$70 for DBCS Education Institutions Members and S\$150 for non-members
- **3** Rationale (100–200 words) to explain the selected grading across the 5 designer qualities

For each Top Seed Award nomination, additional materials are required. This includes:

- **1** Additional Rationale prepared by the nominating staff member that outlines why this nominee stands out nationally across the 5 designer qualities
- **2** Evidence Pack containing project summaries, process documentation, indicators of impact, and testimonials where available

File format: PDF, up to 10 slides

DBCS may request additional materials for verification. All submissions must be submitted through the online platform by 31 October 2025.

Seed Award Benefits

For students, the award provides industry recognition that extends beyond grades, opportunities to connect with like-minded peers, and access to learning and mentoring from industry leaders.

For institutions, it offers a structured and distinctive way to acknowledge their student cohort, align recognition with industry needs and feedback, and gain prestigious acknowledgement of the impact of their design curriculum.

For organisations, the award offers clearer insight into emerging designers' competencies beyond a portfolio and academic certificate, highlighting evidence of the 5 designer qualities and signalling professional readiness.





6 October **Submission** During this period, institutions should enter and complete submissions via 31 October www.seedaward.sg/submission 10 November At the same time, identify up to 3 candidates for the Top Seed Award and prepare the additional materials required for that nomination. 25 November Incomplete or late entries will not be considered.

Submission Deadline

By this date, all institutions must complete their submissions and upload the required materials (where applicable) for each student via the designated online platform.

Upon verification of all completed submissions, DBCS will acknowledge receipt and issue a payment invoice to the respective institutions.

Announcement and Recognition

DBCS provides formal confirmation to institutional coordinators of all Seed awardees and issues official invitations to all participating institutions, together with individual invitations to the Top Seed awardees to attend the DBCS Gala.





6 October **Award Ceremony** All participating institutions are invited to attend, and the Top Seed awardees receive their token award, 31 October presented by the Guest of Honour. 10 November Recognised students and participating Institutes of Higher Learning may be acknowledged in DBCS communications and at the Gala, subject to approval of supplied media assets. 25 November







Are students from different years of study eligible?

Yes, all students in a design-related programme are eligible.

Are graduates eligible?

Yes, recently graduated students (within the previous academic year) are eligible.

What level of rubric assessment will students need to qualify for the Seed Awards?

Students just need to meet the Emerging level of each criteria to qualify for the Seed Awards. There is no need to be Effective or Exemplary in any criteria as we acknowledge that youth are still learning and establishing themselves.

For Top Seed nominations, institutions are encouraged to put forward students who are at least Level 2 (Developing) and preferably Level 3 (Proficient) across the 5 designer qualities.

The criteria and rubrics sound very broad. I'm not sure if this student would qualify?

As we are awarding based on future leadership qualities and not knowledge and ability tests, there will always be a margin of interpretation and ambiguity in the rubrics to acknowledge the richness and complexity that is life. We trust that the IHL will be able to provide stories and evidence for the students upon submission. However, if further clarifications need to be made, DBCS will follow up with the IHL.

How does the Top Seed Award work?

Each institution may grant the Seed Award to any number of eligible students. From these awardees, up to 3 students per institution can be nominated for the Top Seed Award. DBCS judging panel will review all nominations from participating institutions and select 10 nominees to receive the Top Seed Award.





FAQs

If awardees are assessed and decided by the IHL themselves, then what is the role of DBCS?

DBCS trusts in the discernment and integrity of all IHLs, and will support awardee submissions provided that a clear and adequate rationale is given.

DBCS' role is four-fold:

- 1 Provide a set of unifying criteria and broad rubrics for each IHL to determine which students qualify, backed by broad design industry recognition;
- 2 Organise an industry-led panel of judges to identify the Top 10 Seed awardees;
- 3 Provide a prestigious platform to acknowledge the students through our annual Gala, which illustrious industry practitioners, international jurors and experts, and Political Office-Holders will attend;
- 4 Provide social media spotlights for each IHL and their respective Seed Award winners.

Is there another way to submit if I have bulk submissions for the Seed Award?
